Terms And Conditions Of Enrolment

1. All children must be supervised by the parent(s)/guardian(s) for the duration of the swimming lessons. No children may be dropped off without proper supervision.
2. Fees are payable cash or via bank EFT to Super Shark in advance, before the 5th of each month.
3. Full fees are payable during the swimming season. Please note that charges are worked out according to 10 lessons per term. A roster will be kept of your child's swimming time. If you are unsure, please feel free to contact Illse to confirm the time.
4. Please note that swimming continues termly according to the school calendar as set out by the gazette.

5. The swimming school is closed on Public Holidays.
6. Catch-up lessons are reserved for students who were sick! No discount or credit will be given if a lesson is missed due to absenteeism. We try our best to accommodate each learner and parent as far as possible. Feel free to contact Ilse if you need to move a lesson to another time. Please try and do this at least 24 hours before the actual lesson.
7. Swimmers must attend lessons equipped with a suitable swimming costume - no bikinis and baggy shorts are permitted. Swimmers must supply their own towel.
8. Once a single payment has been made it is accepted that the terms and conditions of Super Shark Swim School as set out in this document, are automatically accepted by parent/guardian. The parent/guardian agrees to pay all charges including legal fees which may arise in the event that legal or other action is taken by Super Shark Swim School to recover any fees or amount due, including, but not restricted to, collection commission, whether action is commenced or not.
9. Super Shark Swim School will not be liable for the loss or misplacement of any articles belonging to the swimmer or any person entering the premises of 17 Dennis Circle, Umtentweni.
10. Swimmers must blow their nose and go to the toilet before starting a lesson. For those children who are not toilet trained as yet, please provide special swimming nappies.

11. Should your child misbehave and disrupt a lesson he/she will be given a warning, should he/she persist with such bad behaviour, he/she will be requested to leave the class. Tantrums are unacceptable and it is up to the parent to sort it out.
12. Your child(ren) may not run around the pool surround nor enter the water before or after a lesson without the teacher's permission.
13. **TERMINATING LESSONS:** Membership shall continue for an indefinite period subject to one calendar month written notice, or one month's fees in lieu of notice to be paid on leaving the swimming school. All notices must be in writing and must be hand delivered to Super Shark Swim School no later than the 1st day of your last swimming month. No telephonic or verbal notice will be accepted.
14. **FITNESS TO PARTICIPATE:** I declare that my child is medically and physically fit and able to participate in the Swim Programme. I will immediately notify the Swim Operator of any change to my child's medical condition, fitness or ability to participate. I understand and accept that the Swim School Centre Operator will continue to rely upon this declaration as evidence of my child's fitness and ability to participate in the Programme.
15. **MEDICAL TREATMENT:** I consent to myself and/or my child receiving any medical treatment that the Swim Centre Operator reasonably considers necessary or desirable for me or my child during my child's participation in the Programme. I also agree to

reimburse the Swim Centre Operator for any costs or expenses incurred in providing me or my child with medical treatment.

16. I Indemnify and hold blameless Super Shark swim school, its proprietors, employees, contractors and coaches and the owner of 17 Dennis Circle, Umtentweni against any claims, loss or damages that I or my child may suffer due to an injury, loss of or damage to property that my child or I may suffer on the swim school premises.

I have read, understood, acknowledge and agree to the above terms including the warning, exclusions of implied terms, release and indemnity.
